Bring your horses and ponies to come and play with us! We had a great time at our last play day, even with the weather being unsettled. Here are some images of the people that came out to play.

Cavaletti work is a great way to improve your horse's range of motion and develop top-line strength. Some routines can also help develop symmetry in a horse that is weaker on one side than another. We will introduce some of the exercises from Jec Ballou's book, "55 Corrective Exercises For Horses" during each session. If you attended her lecture, this is putting her words into action. If not, you'll still benefit from this work. Also we will do some exercises from Amelia Newcomb's Strides workshop.

Several cavaletti patterns will be set up to try with your equine partner. We will also set up some different ones than the last session to try. Sessions will begin with simple exercises and increase in complexity up to what the rider./handler feels most comfortable. Most exercises can be done either from the ground or mounted. This is great for horses at all levels of training and for less experienced riders through seasoned show veterans.

Guided instruction will be limited to explaining the pattern and its purpose, assistance with and navigating the patterns and resetting poles as needed. Patterns for the walk, trot and canter will be available to try.

Preregistration is required to manage group sizes. Each group session will last approximately one hour, beginning at 1 PM.
