Ride-A-Test: Sunday April 16: You must be a USDF member to participate in the ride-a-test. (joining RMDS/GVDS will qualify you as a USDF GMO member). Riders will be selected on a first-come, first-served basis and a wait list will be maintained in case of cancellations. There are a limited number of rider spots so get your entry in early.
